Local Law No. 5 of the year 19 92

A local law REQUIRING INDIVIDUALS CURRENTLY SERVING OR WHO SHALL BE SENTENCED TO A PERIOD OF PROBATION UPON CONVICTION OF ANY CRIME UNDER ARTICLE 31 OF THE VEHICLE AND TRAFFIC LAW, TO PAY TO THE ORLEANS COUNTY PROBATION DEPARTMENT AN ADMILNISTRATIVE FEE.

SECTION 1. This Local Law is authorized by Section 257-c of the Executive Law of the State of New York.

SECTION 2. Individuals currently serving or who shall be sentenced to a period of probation upon conviction of any crime under Article Thirty-one of the Vehicle and Traffic law shall pay to the Orleans County Probation Department having the responsibility of supervising the probationer an administrative fee of Thirty Dollars (\$30.00) per month. The Orleans County Probation Department may waive all or part of such fee where, because of the indigence of the offender, the payment of said surcharge would work an unreasonable hardship on the person convicted, his or her immediate family, or any other person who is dependent on such person for financial support.

SECTION 3. The provision of subdivision six of Section 420.10 of the Criminal Procedure Law of the State of New York shall govern for purposes of collection of the administrative fee.

SECTION 4. The probation administrative fee authorized by this Local Law shall not constitute nor be imposed as a condition of probation.

SECTION 5. In the event of non-payment of any fees which have not been waived by the Orleans County Probation Department, the County of Orleans may seek to enforce payment in any manner permitted by law for enforcement of a debt.

SECTION 6. Monies collected pursuant to this Local Law shall be utilized for probation services by the Orleans County Probation Department. Such monies shall not be considered by the New York State Division of Probation when determining State Aid Reimbursement pursuant to Section 246 of the Executive Law of the State of New York. Monies collected shall not be used to replace Federal Funds otherwise utilized for probation services.

SECTION 7. This Local Law shall become effective upon filing by the Secretary of State of the State of New York.
